#### **Course Description**

The course describes the stages of European Union creation, the main steps in European integration. Determinates of the EU founding and current trends are considered.

During the study various aspects of the integrational process are explored: economic integration, industrial, legal, social, Schengen, Eurozone, etc.

It also examines the current development of the EU economy and financial sectors on a whole, as well as of individual EU members. Particular attention is paid to the criteria applied to the countries applying for the EU membership.

#### **Learning Outcomes**

Upon successful completion of this course, students will be able to:

PH1. Responsibly treat professional self-improvement, realizing the need for lifelong learning, show tolerance and readiness for innovative changes.

**Internationality:** The international aspect of the course includes using international statistics and statistics of Eurostat, Reviews and Report on International organizations. Experience of the current EU members with integration in the EU and special attention to the post-Soviet countries like a countries with similar to Ukraine economic system in the past.

### **Student Workload**

It is assumed that for each out of 17 class sessions a student spends about 10.5 academic hours of work. This includes 3.5 academic hours of lectures with the instructor and 7 academic hours of personal work. Personal work includes preparing for the tests, searching extra material on the topics of classes and essays, working out of group project, writing scientific theses for students conferences.

Please pay attention that 1 academic hour equals to 40 minutes.

### **Assignment Format**

• All work should be shown in time. If the student misses the deadline – the task is failed.

• Midterm covered topics from previous lectures (weeks 1-6). It included multiple choice questions and essays and took about 1.5 hours.

• The Final exam covered all course material and included multiple choice questions and essays. It lasts for 1.5 hours. Admission to the Final exam is possible only if all the tasks of the curriculum are covered.
